

# International Student Award –Terms and Conditions

## Terms and Conditions

### 1. Background

The UNSW International Student Award is available to eligible students from lower income and developing countries who would not otherwise have the opportunity to undertake studies at a highly ranked Australian university. The Award is open to all commencing students with defined citizenships enrolled full time in an eligible undergraduate or postgraduate coursework degree.

### 2. Eligibility

- a) To be eligible for the Award, applicants must be an international student as defined in the Higher Education Support Act 2003, and must not be a permanent resident or citizen of Australia, or a citizen of New Zealand.
- b) Applicants must hold citizenship in a country listed in Attachment A. Proof of citizenship will be required.
- c) Applicants must have an offer of admission for a new undergraduate (including UNSW Diploma) or postgraduate coursework degree at UNSW to be offered the Award.
- d) The Award is not applicable to students studying any program offered by AGSM, UNSW Online, UNSW Canberra, UNSW Foundation Programs, Transition Program Online, any program taught in the Hexamester calendar or Study Abroad students.
- e) The Award is only applicable to degrees where tuition fees are payable to UNSW.
- f) The Award is only applicable to coursework degrees. In the case of a combined coursework and research degree, the Award is only applicable to the coursework component of the combined degree.
- g) The Award is applicable to new students commencing from Term 1 2022. Students who have completed an undergraduate program at UNSW and are commencing a postgraduate program will be considered a new student for the purposes of the Award.

### 3. Selection Criteria

- a) To be successful in obtaining the Award, applicants will need to meet the entry criteria for admission to an undergraduate or postgraduate coursework degree at UNSW; and
- b) Submit an acceptable personal statement outlining their motivation to study at UNSW.

#### **4. Value**

- a) Award recipients will receive a 15 percent contribution to their tuition fee from the University for the duration of their program.
- b) No payment will be made directly to the student, the Award will be applied to the applicants' record which will reduce the applicants' overall tuition fee liability.
- c) No other amount is payable.

#### **5. Ongoing eligibility**

- a) To continue receipt of the Award, the recipient must:
  - a. have no outstanding fees
  - b. maintain full time enrolment
  - c. be enrolled in an eligible program

#### **6. Termination**

- a) The Award will be terminated if the recipient:
  - I. graduates from an eligible program
  - II. withdraws from an eligible program or fails to enrol
  - III. becomes a domestic student
  - IV. fails to complete their program in the given timeframe indicated in their Certificate of Enrolment (CoE)
  - V. is determined by the University to be guilty of serious misconduct, including, but not limited to, having provided false or misleading information as part of their application; or
  - VI. any other provision as indicated in these terms that would lead to termination.

#### **7. Other Requirements**

Award recipients may be invited to promote the program in which they are enrolled as well as represent UNSW at student events, marketing events and corporate networking events. The costs of representing UNSW at these functions will be met by the University.
